

Chairman's Column - July 2025



Our preparations with CRT to re-start work have continued. But despite every effort by ourselves, all discussions with CRT have continued to be much

slower than we would like or expect. It seems that we are not alone in finding CRT slow to respond to restoration initiatives.

The Waterways Recovery Group subsidiary of the Inland Waterways

Association publish a bi-monthly magazine "Navvies" describing progress. In the latest issue, their chairman Mike Palmer describes how slow response from a different region of CRT has caused the cancellation of a planned week-long canal camp.

Last time I described that we would finalise detailed proposals for the limited amount of remediation which we have to do. A company named Southern Testing who have helped us before, completed a "Remediation Strategy" which we sent to CRT for review. CRT have asked for some changes which are in hand.

I also said that we needed to complete our contractual negotiations with CRT. The more detailed document which we were expecting turned out to be something called a Licence Agreement, which CRT finally sent on Friday 9th May. But despite being a relatively short document, we had three high level issues with it, which were more operational than legal – in several ways it just didn't seem suitable for our situation, for example it assumed that we would be subcontracting all work rather than doing it ourselves.

On Monday 12th May I asked for a face-to-face or Teams meeting to discuss our issues, and I sent CRT our three high level points a week later. But the rest of May and June passed without even a date in the diary. Finally on the last day of June, CRT told us that they will be sending an updated document before putting a date in the diary. It arrived and looks much better, but we still need to discuss some final points with them, which we

will be doing on Tuesday 22nd July.

The water which flows down the Wendover Canal remains around half the supply to the Tring summit of the main line of the Grand Union Canal. Our restoration will make this more resilient by reducing leakage from the current underground pipes. The hot dry early summer has shown how important is this supply. Last winter, CRT were unable to fully refill Wilstone reservoir because of the need for its strengthening. Boating restrictions have started.

On Monday June 16th, the 16 narrow locks of the Aylesbury Canal were closed to save water. For a few days at the start of July, key locks either side of Tring summit such as Marsworth and Cowroast were limited to a supervised 4 hours per day, with a warning that there might be closures at no notice, though this has just been lifted because they say that they have found a better way of pumping water.

CRT have just started driving two thousand eleven-metre-long steel piles to strengthen the embankments of Wilstone reservoir. The piling is expected to take 5 months. Walkers have been diverted from the footpath along the top of the bank, into the nearby field. The Wilstone reservoir car park will be closed from September for around four months. The road next to this car park will be closed for approximately the month of September. Meads farm shop and café will remain accessible, they have helped us so please use them if you can.

Quite separately from our discussions with CRT, a different part of CRT has published draft national proposals for what they have called a Restoration Delivery Plan. I have represented us on an IWA Zoom to discuss this. A key proposal is that volunteer canal restorers such as ourselves should pay CRT forty pounds per hour to cover the costs of CRT forming a national team to work with us. Some of the WCT trustees would consider this if it is applied to us, and so would some other canal restoration groups. But personally, as someone who has been involved with various canal restorations for over 50 years. I think this is just wrong in principle. Hopefully our Licence Agreement will avoid the need for us to be further affected by this

Graeme's larger than life personality was well suited to the many and varied demands of Site Management, and it was therefore no surprise that the Festival grew in size and local esteem over the vears. One memorable occasion was when Graeme and his twin brother lan brought a nearly finished narrowboat to the Festival, and completed it in public on dry land alongside the Arm during the Festival, before handing it over shortly afterwards. The festivals sadly ended when we lost the use of the festival field after it changed hands."

Finance Review 2025

The provisional accounts for the year to 31st March 2025 show total income for the Trust of £54,657, 50% up on the previous year, and expenditure of just £18.658. Therefore there is a surplus of £36,000 for the year, and the updated cash position from Paul Armstrong shows available funding of £439,430 as at 31 March. Consolidated income, including the subsidiary company Wendover Canal Restoration Ltd, was £69,500 and group surplus £47,400.

However there were one time receipts during 24/25 of £14,837 for grants (via WCRL) and £7,700 in a legacy, plus fundraising event income of £5,000, so forecast income for 2025/6 is considerably reduced at £39,000.

Total charitable funds as shown on the balance sheet increased by 8% to £475,000.

As expected, there has been very little expenditure since 31st March. A provisional allowance has been made for restoration costs of £60,000 in the current year, giving a total expenditure of £80,000, and a net expenditure of £40,000 for the Trust at the end of the year. Therefore the forecast level of cash and funds is likely to remain at about £400,000 in March 2026. It is now clear that there are sufficient funds available to take the Trust through the following year to 31st March 2027, but the total cost of canal restoration over the next three years will be in the

region of £800k, and the project therefore cannot be completed without seeking further funds. Therefore it will be necessary to start discussions with CRT and others concerning funding beyond 2027 later this year.


